A First Course in Linear Algebra Springer Nature

Consider a rational projective curve \mathcal{C} of degree d over an algebraically closed field k . There are n homogeneous forms g_1, \dots, g_n of degree d in $B = k[x, y]$ which parameterize \mathcal{C} in a birational, base point free, manner. The authors study the singularities of \mathcal{C} by studying a Hilbert-Burch matrix φ for the row vector $[g_1, \dots, g_n]$. In the "General Lemma" the authors use the generalized row ideals of φ to identify the singular points on \mathcal{C} , their multiplicities, the number of branches at each singular point, and the multiplicity of each branch. Let p be a singular point on the parameterized planar curve \mathcal{C} which corresponds to a generalized zero of φ . In the "triple Lemma" the authors give a matrix φ' whose maximal minors parameterize the closure, in \mathbb{P}^2 , of the blow-up at p of \mathcal{C} in a neighborhood of p . The authors apply the General Lemma to φ' in order to learn about the singularities of \mathcal{C} in the first neighborhood of p . If \mathcal{C} has even degree $d=2c$ and the multiplicity of \mathcal{C} at p is equal to c , then he applies the Triple Lemma again to learn about the singularities of \mathcal{C} in the second neighborhood of p . Consider rational plane curves \mathcal{C} of even degree $d=2c$. The authors classify curves according to the configuration of multiplicity c singularities on or infinitely near \mathcal{C} . There are 7 possible configurations of such singularities. They classify the Hilbert-Burch matrix which corresponds to each configuration. The study of multiplicity c singularities on, or infinitely near, a fixed rational plane curve \mathcal{C} of degree $2c$ is equivalent to the study of the scheme of generalized zeros of the fixed balanced Hilbert-Burch matrix φ for a parameterization of \mathcal{C} .
