Equally, they scrutinize the structural and ideological factors which limit the Church's capacity for influencing public discussion. Recent and wellpublicized shifts in the Church's official positions are explained by reference to the complex interaction of long-term social, political, and theological developments. The result is a volume which not only adds to our understanding of a significant yet little-charted area of English politicallife, but which is also intended to enhance the Church's own self-understanding.

Lordship and Faith takes as its subject the many hundreds of parish churches built in England in the Middle Ages by the gentry, the knights and esquires, and the lords of country manors. The Reform of the Papacy A&C Black

Archaeological work at 1 Poultry includes analysis of 280 burials associated with the medieval church of St Benet Sherehog and a post-Great Fire burial ground on the same location. Post-medieval coffins and coffin furniture indicate that the burial population is primarily late, with a fifth dated to before the Great Fire, although none were associated with the primary phase of the church. The parish of St Benet Sherehog pre- and post-Fire is considered in terms of the documented population, occupations and wealth, and health and mortality. This is followed by evidence for the medieval church of St Benet and the religious life of the parish. 'Death and commemoration' looks at historical and archaeological evidence for funerals and burial practices. A detailed osteological account of the 17th- to 19th-century burial sample includes comparison with contemporary London cemetery populations.

The Catholic Church remains one of the oldest institutions of Western civilization. It continues to withstand attack from without and defection from within. In his revision of American Catholicism, Monsignor Ellis has added a new chapter on the history of the Church since 1956. Here he deals with developments in Catholic education, with the changing relations of the Church to its own members and to society in general, and especially with arguments for and against the ecumenical movement brought about by Vatican Council II. The author gives an updated historical account of the part played by Catholics in both the American Revolution and the Civil War, and of the difficulties within the Church that came with the clash of national interests among Irish, French, and Germans in the nineteenth century. He regards immigration as the key to the increasingly important role of American Catholicism in the nation after 1820. For contemporary America, the author counts among the signs of the mature Church an increase in Church membership, the presence of nine Americans in the College of Cardinals in May, 1967, and the expansion of American effort in Catholic missions throughout the world.

The Reformation and Rural Society Zeticula

This book provides the first in-depth case study of 'Renew' - a pastoral programme of religious revitalization. The programme originated in the United States in 1976 and has been widely adopted throughout the Roman Catholic world. Initiated from the top down in a hierarchically-structuredchurch, it can be seen as an example of clerical attempts to stimulate and control lay spirituality in an organizationally controlled manner (as opposed to grass-roots movements, such as those associated with liberation theology).The authors look at the history of religious organizations in the Roman Catholic Church and the affects of modernity on religious practice, and the decline in the latter which prompted the diocese to adopt 'Renew'. Their findings show that the effects of 'Renew' were limited and short-lived, aninevitable consequence of the ambiguous and often contradictory aims. In analysing these findings they suggest some ways in which the church might reform itself - by decentralization and a reform of the papacy, for example - to meet the challenges of the modern age.

The Oxford Handbook of Later Medieval Archaeology in Britain B T Batsford Limited

The Companion is a comprehensive, fully illustrated A-Z guide to all aspects of the English parish church - of which there are 18,000 dating from the post-Roman period to the present day. Subjects include architecture, fittings and furnishings, decorative and allegorical features, stained glass, monuments, brasses and effigies, traditions and folklore, parochial and vestry administration and records, and the role of the parish church in the history of a community. Entries vary in length from one-line definitions of terms to several pages in which subjects are considered in depth. The Companion is arranged alphabetically and consists of a number of primary entries from which cross-references lead on to a larger number of secondary entries. Many of the terms encountered when visiting or researching a parish church are also included, either as short individual entries or by cross-referencing. The book is illustrated with over two hundred line drawings, maps and photographs and includes suggestions for further reading, an index of churches and a list of useful addresses.

Discovering English Churches Oxford University Press

Colin Cunningham looks at how parish churches have developed as patterns of worship have altered. He also shows what prompted renovations over the centuries and how church practice responded to innovations in layout. Having traced the roots of Anglican church building back to the earliest centuries of Christianity, including elements of paganism that have been absorbed into Christian worship, the author covers the development of the sacraments in the pre-Reformation era, and the traditions of prayer and preaching that developed thereafter. The ritualist revival of the 19th century and the liturgical revival of the 20th are described in relation to the buildings and equipment they fostered. Churches are also considered not only as buildings encompassing a range of activities, but also in relation to their setting and the variety of activities that have taken place in and around them.

Beginning with Catholic attitudes to the Act of Union this work traces various elements in the interrelationship between the Catholic Church and the

state in Ireland in the 19th century. Catholicism's role in the Protestant state for most of the century was tempered and conditioned by its relationship with the various Protestant churches in the country. In the development of its infrastructure, facilitating as it did along with other factors the 'devotional revolution', the church was in many ways dependent upon Protestant financial help. The ironies and complexities of this situation is a consistent theme in these essays. Although the religion of the vast majority of the Irish people Catholicism, in its institutional aspect, felt itself to be undervalued and underappreciated by the Protestant state. Its dealings with the state were tempered by its relative poverty and its dependence on the state for various benefactions not least the generous provision for Catholic clerical education. For the first time in the historiography some attention is paid to the relations between the Catholic Churches in Ireland and England in an era when the future cardinal Nicholas Wiseman attempted to pose as an unofficial adviser to government on Irish and Vatican affairs, in circumstances which caused resentment among Irish Catholic churchmen.

The Church of Ireland has received a considerable amount of attention recently from nineteenth-century historians but few have looked at it from the perspective of the local community, as has been the case with recent work by historians in Britain. This study of the church in Victorian Dublin begins with a survey of the development of the parishes and the building of churches. It examines the devotional life and pastoral concerns of the laity and the clergy and their changing roles. An analysis of churchgoing trends is included and comparison is made with trends in England and Scotland. The study includes developments in church architecture, the layout of church buildings and the content of church services. This is set in the context of the demographic changes and the overall decline in the church's population in Dublin. While the study addresses the religious rivalry which existed between Catholics and Protestants, it also includes consideration of the laity's role in the management of the day-to-day life of the local church

community. The social and educational backgrounds of the clergy are discussed and an account is given of their training and the changing process by which they were appointed to parishes. The study suggests that trends in the Church of Ireland in Dublin at the time were not dissimilar to the Church of England and both churches experienced a religious boom in the period. However, disestablishment in 1870 and the church's minority status gave the Church of Ireland a distinctive social and religious flavour.
